

## **NOTICE TO INTERNATIONAL HERBALIFE INDEPENDENT DISTRIBUTORS WISHING TO DO BUSINESS IN LEBANON OR SPONSOR LEBANESE NATIONALS**

Any Herbalife Independent Distributors who is not a Lebanese national (non-Resident of Lebanon) and who is not travelling to Lebanon for the Distributor event on September 3, 2011, but wish to register Lebanese prospects should use the official Herbalife International Distributor Registration process. Please, do so by providing the required information and acceptance of the *Terms and Conditions* set forth below.

### **International Distributor Registration Policy for Lebanon**

#### **1. Policy**

##### **1.1. Registration**

- As an International Distributor, you must enter your name, Distributor Identification Number and Contact Information into our system online
  - The online registration system can be found at:

  - If you are unable to complete the registration process online, please sign and date this acknowledgement form and return it to the Herbalife Distributor Services team in Greece (contact information is below)
- Upon completing your online registration, a confirmation will be sent via e-mail to you and the Herbalife's Distributor Services team

##### **1.2. International Registration Number**

- Upon completing your online registration, you will receive a unique International Registration Number (found in the confirmation e-mail)
- This number does not replace your Distributor Identification Number
- You must supply any of your prospective Lebanese Distributors with this registration number, along with your own Distributor Identification Number
- Your prospective Lebanese Distributor must enter the International Registration Number and your Distributor Identification number (as their Sponsor) on their Distributor Application document found within the purchased International Business Pack (IBP)
  - The International Registration Number should be written in the top right corner under the preprinted Distributor Identification Number on their *Distributor Application*
  - Your Distributor Identification Number (as their Sponsor) must be entered under the Sponsor Information on their *Distributor Application*
  - In doing so, the prospective Lebanese Distributor will be assigned as your downline
- IBPs will be available for purchase directly at the Sales Center

### 1.3. Duration

- This policy will be in place for two months from the Lebanon Distributor event: Beginning on September 3, 2011, and ending on October 31, 2011

## 2. Restrictions for International Herbalife Independent Distributors

International Herbalife Independent Distributors are considered non-Residents and can:

- Purchase products for personal consumption with a purchasing limit of 1,000 Personally Purchased Volume Points per month, in accordance with Herbalife's Import/Export Policy. Product sales by non-Lebanese Distributors are not allowed unless these Distributors have met the requirements set forth in the *Key Points* document
- Promote products
- Recruit in compliance with local legislation
